

SOUTHWEST NATIONAL BANK ONLINE BANKING AGREEMENT

This agreement is made and entered into by and between _____
A Corporation/partnership/Association/Sole Proprietorship/Limited Liability Company (hereinafter the "Company") and SOUTHWEST NATIONAL BANK (hereinafter "Southwest National").

The Company has requested to be granted access to Company accounts (including loans) via Southwest National Bank Online banking, an Internet PC based account access system (hereinafter referred to as the "Service"). In consideration of Southwest National providing the Service to Company, the parties agree as follows:

1. Upon initial login, the Company will create a password for online banking. The Company may, at the Company's sole discretion provide this password to individuals authorized by the Company to access the Company's accounts via this Service.
2. The Company will be solely responsible for changing the password whenever the Company deems necessary for security reasons or due to changes in personnel.
3. The Company recognized that all persons possessing the password for the Service will be able to perform the following activities with limitation in regards to the accounts and loans of Company through the Service:
 - Obtain information with regard to accounts and loans for the Company, including balances and transaction history.
 - Transfer funds between Company accounts
 - Change the Company's password and login ID
 - Initiate external transfers to and from another financial institution
 - Initiate bill payments and transfers
 - Access the mobile banking app
 - Make deposits using the mobile banking app

Company acknowledges that the online bill paying service and the external transfer service may be used to initiate payments to third parties from deposit accounts of Company with no limit in number or amount. Company understand that this could lead to a loss of funds in the Company's account if used in an unauthorized manner.

4. Company has read, understands and agrees to the Account Terms and Conditions and the Internet Banking agreement, which further govern use of the Service.
5. Company releases Southwest National from, and Company shall indemnify, defend and hold harmless Southwest National Bank, its employees, officers and directors, against and with respect to any and all loss, liability, expense and damage, including consequential special and punitive damages, attorneys' fees and other litigation costs, directly or indirectly resulting from:
 - Any unauthorized individual obtaining the password of the company.
 - Any unauthorized transaction or unauthorized receipt of information in connection with any use of the service whether by authorized or unauthorized personnel.
 - Any loss to the Company resulting form any unauthorized use of or any transaction made by the use of the online bill paying service, if such service is later requested by the Company.

The use of the Service granted herein to the Company shall remain in full force and effect until written notice of termination of the Service shall have been delivered to Company by Southwest National or until event Southwest National shall have a reasonable time to terminate Company's use of the Service, in which event Southwest National shall have a reasonable time to remove Company's accounts from the Service. The Agreement of company in Section 5 above shall survive any such termination indefinitely.
